**A RESOLUTION AUTHORIZING THE USE OF SOURCEWELL COOPERATIVE PURCHASING
CONTRACT FOR SECURITY CAMERA SYSTEM PROCUREMENT**

WHEREAS, the Roselle Public Library District ("Library District") is authorized under Section 40-45(a) of the Illinois Public Library District Act (75 ILCS 16/40-45(a)) to enter into contracts and to join with other governmental entities in cooperative purchasing agreements for the acquisition of goods and services; and

WHEREAS, the Library District is further authorized under the Illinois Governmental Joint Purchasing Act (30 ILCS 525/0.01 et seq.) and Article VII, Section 10 of the Illinois Constitution to participate in joint purchasing programs and to acquire goods and services through contracts awarded by other governmental entities that have conducted a competitive solicitation process; and

WHEREAS, Sourcewell (formerly known as the National Joint Powers Alliance) is a public service cooperative created under the laws of the State of Minnesota that conducts competitive solicitations for products and services and makes those contracts available to participating public agencies, including Illinois library districts; and

WHEREAS, the Library District is a registered participating agency of Sourcewell (Agency ID No. 129034), and Securitas Technology holds a current Sourcewell contract for security camera systems that was competitively awarded by Sourcewell; and

WHEREAS, pursuant to the Library District's Bids and Contracts Policy, competitive bidding is generally required for purchases exceeding \$25,000 unless the purchase is made through a cooperative purchasing program that has already competitively bid the contract; and

WHEREAS, the Board of Library Trustees finds that utilizing Sourcewell for the procurement of security system design and installation services from Securitas Technology will achieve competitive pricing and administrative efficiency consistent with the Library's policies and applicable law;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Roselle Public Library District that:

The competitive bidding process is hereby waived for this procurement pursuant to the Library District's Bids and Contracts Policy and the authority granted by 75 ILCS 16/40-45(a) and 30 ILCS 525/0.1 et seq.; and

The Executive Director is authorized to procure security camera system design and installation services from Securitas Technology under the applicable Sourcewell cooperative purchasing contract, consistent with the Library District's budget and policies; and

The Executive Director is further authorized to execute any and all documents necessary to effectuate the purchase and to maintain documentation evidencing compliance with the Resolution.
